

**Promotional Campaign: Conditional Jet Vouchers: Sales Campaign
(Campaign period: 18 July to 31 August 2019)**

1. The promoter of the campaign is African Bank Limited (“the promoter”).
2. Only persons who are 18 years or older and are resident within the Republic of South Africa will form part of this promotional campaign.
3. Employees, directors, and agents of the promoter, their immediate families, life partners, business associates, any advertising agencies of the promoter, their printers, their marketing suppliers and their family members and any person directly involved with the deriving, production, management or marketing of this competition are not eligible to participate in or enter this competition.

10. Qualifiers will be contacted on the 3rd of September 2019 via SMS. The SMS will contain a discount voucher number which can be used at a Jet Store. Vouchers are valid until 30 September 2019.
